

THE FOOTBOWL CHALLENGE Rules and Regulations

- Employees of participating centers are ineligible.
- Entry fee is \$50, \$25 towards prize fund and a \$25 donation to BVL (Bowlers to Veterans Link).
- Register before October 28, 2024, to become eligible for a \$500 Visa gift card drawing.
- After completing the registration form, players must **Sign Up** and create an account.
- Players must **Login** to their account prior to each bowling session.
- When logging in, select your center; the lanes you are bowling on; select cross lane; your position; and enter your name that matches the one in the bowling centers scoring system; then start playing.
- Not logging in will result in zero points.
- Grand prize of \$5,000 and the 1st prize in each of the 5 centers consisting of a 2 night stay at Sante Fe Station Hotel & Casino, along with a \$750 airline voucher (a \$1,000 value) is guaranteed.
- Hotel accommodations and airline voucher may not be redeemed for cash.
- \$25,000 prize fund based on 320 total entries, 64 per center. The top 16 per center win cash and prizes.
- Prize Ratio 1:4.
- JAM-N Enterprises is adding \$17,000, with 320 entries, to create the \$25,000 prize fund.
- If a 1st place in house winner is unable to travel to Las Vegas, the hotel accommodations and airline voucher is waived, and a player receives 5th place grand prize money of \$1,000.
- Players can only compete in one league as designated on the registration form.
- Any other attempt to gain points will result in a disqualification and loss of entry fee.
- Qualifying begins Monday, November 4, 2024, and ends January 19, 2025, for a total of 11 weeks.
- There will be a Bye week.
- Best 10 of 11 weeks will be used to determine total points.
- Bowlers compete in their league and earn points based on results of each frame, which determines a FootBowl play. View table of FootBowl plays results on “Game Rules” page.
- Bowlers are matched each week against their opposing position.
- Offensive points are awarded for gains of yards and touchdowns.
- Defensive points are awarded for loss of yards, interceptions, and fumble recoveries.
- View points table on “Game Rules” page.
- Players are encouraged to read the game rules of the FootBowl game on the “Info” page.
- Points are accumulated each week during the qualifying period and can be viewed on the “Standings” page.
- In the event of a tie for 1st place In House, 1 game of FootBowl will be played (to be scheduled by center). Points will not be used. The final score of the FootBowl game will determine the winner.
- Grand finals to be held in Las Vegas, NV at Sante Fe Station Bowling Center on February 9, 2025, at 10:00 am. This will be a step ladder format.
- Top points earner out of the 5 centers will be seeded #1.
- In the step ladder format, players bowl 2 games of FootBowl. Each game represents a half. The FootBowl score from each game will be added together for a final score. The winner advances.
- **Participating centers are not responsible for the event. All discrepancies, disputes, and system malfunctions should be directed to JAM-N Enterprises, via the “Contact Us” page. All determinations will be deemed final.**
- In house prize money will be awarded within 1 week after conclusion of qualifying period.
- Grand final prizes will be paid on the spot in Las Vegas.
- The IRS requires JAM-N to furnish 1099 forms to individuals who accumulate winnings of more than \$599 annually in any JAM-N event in which they participate.
- Failure to furnish Social Security Number or Tax ID when requested, for prizes greater than \$599, will forfeit prize money.
- By entering this event, the bowler grants his/her consent to JAM-N to use his/her name and/or likeness for promotional purposes, without compensation.
